nitrofurantoin monohydrate and macrocrystal 100 mg capsule Commonly known as: MACROBID Take 1 capsule by mouth two times a day for 5 days.



ondansetron 4 mg tablet Commonly known as: ZOFRAN Take 1 tablet by mouth every 8 hours as needed for nausea/vomiting.
